${ }^{1}$ All returns are from Bank of New York Mellon (BNYM) and are time-weighted, total return calculations, net of fees and expenses. All returns are expressed in U.S. dollars. Periods greater than one year are annualized. Fiscal Year ends June 30th. Policy benchmark is the blend of the asset class policy benchmarks using policy weights. Asset class benchmarks and policy weights are reviewed annually by the Commission's consultant and adopted by the Commission and have changed over time. The policy benchmark return history represents a blend of these past policies.
${ }^{2}$ Effective 10/1/2005, the State Retirement System Preservation and Investment Reform Act established the Commission and devolved fiduciary responsibility for investment and management of the assets of the South Carolina Retirement Systems upon RSIC. The actuarial assumed rate of return is $7.50 \%$ starting with the assumed rate of returns after $7 / 1 / 2011$, and is composed of an assumed $2.75 \%$ inflation rate and an assumed $4.75 \%$ real rate of return, net of investment and administrative expenses.
${ }^{3}$ Total Plan allocations and returns are based on values obtained from BNYM and adjusted for overlay exposures based on information provided by Russell. Total Hedge Fund exposure at $12 / 31 / 16$ comprised $11.0 \%$ and consisted of: $8.1 \%$ Portable Alpha Hedge Funds, $0.8 \%$ to a hedge fund in Mixed Credit, and $2.2 \%$ Hedge Funds (Non-PA). Global Public Equity, Public Real Estate, and Mixed Credit target weights float based on their private market counterpart as highlighted in the SIOP.

${ }^{5}$ "Cash" market value is the aggregate cash held at the custodian, Russell Investments, and strategic partnerships. *Portable Alpha Hedge Funds are expressed as gross exposure but, as collateral supporting the Overlay Program, net to zero when calculating total Plan market value.
